
Clearly, we see the members of our pastoral team each and every weekend as we join with our fellow believers in worshipping our Lord individually and as a congregation. We know what our team does during the weekend – but what about all week? What does a pastor do? What activities fill their schedules?

If you have ever called the office to seek pastoral assistance, you know that our pastors stand ready to confidentially assist families with personal and spiritual crises. And meeting the needs of our members takes priority for our pastors over any of their day-to-day activities. Our pastors are called to provide counseling for couples considering marriage and for families experiencing health issues. They also provide support for families as they experience loss and for those who need comfort during an emergency.

As is evident every Sunday morning, our team is active in worship-planning. What we *don't* get to see are the hours of preparation that lead to our worship. First is our pastors' personal study time. While the process of sermon preparation varies from pastor to pastor, members of our team can spend upwards of 20 hours reading, studying and preparing for a sermon.

But there is even more to the normal week. Each of our pastors has a focus area that takes time and energy, as described underneath their photos above.

Whether our pastors are preparing for worship, engaged in Bible Study, conducting meetings, counseling members or celebrating weddings, they are active in a vibrant ministry guided by our Lord and blessed with the energies of countless members as our community of believers seeks to serve our Lord and His people.



Pastor Mark Brandt serves as our Lead Pastor. In addition to standard pastoral team duties, Pastor Brandt is responsible for the administration of our congregation. He coordinates the pastoral team, works with the Ministry Council and oversees the work of our staff. The list of administrative tasks can get very long, and Pastor Brandt works closely with our staff to meet the needs of the congregation.





Pastor Brandt attended Concordia Jr. College in Ann Arbor, Michigan, and Concordia Sr. College in Fort Wayne, Indiana, before completing his seminary training at Concordia Seminary in St. Louis, Missouri. He was confirmed at St. Peter’s Lutheran Church in Columbus, Indiana, where his father was pastor.

Pastor Brandt served his vicarage in Sioux City, Iowa, at Calvary Lutheran Church. Late St. Lorenz Pastor John Deterding once served that congregation and had been installed at Calvary Lutheran by Pastor Brandt’s father.



## A letter from our President

Greetings:

It is hard to think of our Foundation without focusing on the faithful leaders who have served on our board and committees over the past 20-plus years. Since the founding team encouraged our congregation to take the assets of the St. Lorenz Perpetual Trust and form the St. Lorenz Foundation, we have had many faithful men and women serve as stewards of our members' financial resources.

2018 was a busy year for the Foundation – from hosting tax seminars to supporting our congregation as it embarked on a building program. In all, our Foundation board approved distributions of \$653,718 in grants. We also paid our first installment of a four-year, \$1 million pledge in support of the Worship and Event Center.

The majority of the grants issued by our Foundation are earmarked by the donors. These designated grants provide the funding for our Dedicated Projects, such as Lead Pastor expenses, our Vicar Program, scholarships and more; see page 13 for a complete listing. In particular, our Foundation board is working diligently to grow the designated Missions Fund so additional funds can be distributed for missions in the future.

The St. Lorenz Foundation exists as a vehicle for our members to provide ongoing support for our church and school. Through the Foundation, we are able to help our congregation focus on its ministry and dream of ways to be even better at meeting the needs of our people.







# Grant-Funded Projects

*Grant-Funded Projects are those that are funded by the board based on grant requests from St. Lorenz Lutheran Church and School. These grant requests are processed by the Planned Giving and Estate Planning Committee and forwarded to the board for action. For calendar year 2018, the total distributed was \$321,830.*

**School Security Video Surveillance** – Our school has a video surveillance system to assist in identifying inappropriate behavior as well as securing our facility. This grant allows extension of the system to areas not previously covered.

**Amount granted: \$10,000**



**Church Office Business Evaluation and Office Manager Transition** – Our church office strives to meet the needs of our members as well as support our pastors and congregational leaders. This grant provides resources to evaluate the office operation and assist in the transition to a new office manager.

**Amount granted: \$35,000**

**Comprehensive Security Assessment** – Recent attacks at places of worship and at schools make it necessary to address building and program security. This grant provides funding for a security consultant to review our programs and make recommendations for adjustments to our current policies and practices.

**Amount granted: \$12,500**



**Comprehensive Background Checks** –

As a licensed childcare facility, it is necessary to have all workers fingerprinted and screened by the State of Michigan's selected vendor. While there will be ongoing costs as workers change, this grant provides funds to pay for the initial screening necessary for compliance.

**Amount granted: \$3,705**

**Upgrade to Pastors' Wireless Microphones** –

The FCC made changes to its frequency allocations, making it necessary to change our microphones to a new frequency. This grant allows for the upgrade of the microphones.

**Amount granted: \$11,000**



**Security Video Surveillance System for Church Exterior** – Securing our building and property continues to be an important task. This grant provides funds to extend video surveillance capabilities to include the church parking lot and building exterior.

**Amount granted: \$11,000**

**VLHS Scholarships** – St. Lorenz helps our members attending Valley Lutheran High School. This support is provided through both the congregation's funds and Foundation grants.

**Amount granted: \$9,775**



**Room 202 Remodeling** – Room 202 is a conference room that serves many organizations in the congregation and school. This grant provides updates for the room, including fresh paint, drywall and wood trim, as well as furniture.

**Amount granted: \$5,000**

**Childcare Classroom Management System and Enhanced Learning** – Parents of childcare-aged students welcome and encourage regular communication with the school. This grant provides funds for a program called Tadpoles, a platform for two-way interaction. This grant supports the installation of the program, as well as iPad® mobile digital devices for use with the program.

**Amount granted: \$19,500**

**School Learning Management System** – This grant provides resources for the development of a Learning Management System for our school, including instructional design as well as curriculum management.

**Amount granted: \$32,000**



**St. Lorenz Church Stained Glass Restoration** – There are 12 round stained-glass windows around the balcony in the Church requiring restoration.

**Amount granted: \$20,850**

**Environmental Education Program** – This grant provides the resources for a part-time naturalist to offer outdoor education programs to our students. By making use of the Churchgrove and area resources, students gain an appreciation for God's creation!

**Amount granted: \$15,000**

**Transportation for Clio Students** – Approximately 30 students from the Clio area attend St. Lorenz. This grant provides funding to assist with their transportation.

**Amount granted: \$2,500**

**Classroom set of iPad® Mobile Digital Devices for 1st Grade** – Our school added a classroom this year and has increased the use of iPad® mobile digital devices for student learning activities. This grant provides funds for replacing depreciated equipment and providing for the new classroom.

**Amount granted: \$15,000**

**TEC21** – TEC21 is a teacher training program to help prepare teachers for using the technology equipment and programs available to them in the instructional process. This grant provides funding for teachers' participation in regional workshops.

**Amount granted: \$3,000**

# Grant- Funded Projects (continued)

**Instructional Technology Coach** – Our school has received the services of a part-time Instructional Technology Coach in recent years. The coach provides classroom support for teachers as they integrate technology into the instructional process.  
**Amount granted: \$35,000**



**Deaconess Intern** – A Deaconess intern assists our congregation by serving as our Sunday School Superintendent, visiting nursing homes and working with focused women’s Bible study classes. The intern also assists with the children’s ministry program at the Franklin Avenue Mission.  
**Amount granted: \$6,000**



**National LCMS Youth Gathering** – The LCMS is hosting its National Lutheran Youth Gathering in Minneapolis in 2019. This grant assists the estimated 25 youths and five chaperones planning to attend.  
**Amount granted: \$10,000**

**175th Anniversary Celebration** – St. Lorenz is celebrating its 175th Anniversary in 2020. This grant will be used to help fund special speakers during the celebration year. Plans call for returning vicars, musical groups and nationally known speakers.  
**Amount granted: \$35,000**

**Congregation Vision-Setting Process Support** – The Ministry Council requested funds to have a consultant assist congregation leaders in developing a Vision and direction for 2020 and beyond.  
**Amount granted: \$10,000**

**Kitchen Improvements at the Rock** – The St. Lorenz “Rock” building is used by our youth program as well as many other organizations. This grant helps fund remodeling of the building’s kitchen facilities.  
**Amount granted: \$15,000**



**Small Group Bible Study** – This grant provides video and print resources to support the “Joining Jesus on His Mission” small group Bible study program.  
**Amount granted: \$5,000**

**Pastoral Ministry** – Two dedicated accounts have been established to support pastoral ministry at St. Lorenz. Through a generous gift, the Board of Directors established the Pastoral Endowment. This fund provides resources on an annual basis to assist the congregation with expenses related to the pastoral team. The second account providing support for the pastoral ministry is the Vicar Endowment. This fund has been established to support the expenses of the Vicar Program.  
**Amounts distributed: \$142,773 (Pastoral Endowment) and \$39,464 (Vicar Endowment)**

**Missions** – Two donor-designated accounts provide funding for mission work. The funds support a variety of mission programs and projects, and the Foundation Board of Directors has committed to helping build the account for mission projects. The congregation submits grant requests for missions, and the board selects and awards the grants.  
**Amount distributed: \$10,419 (mission trips and POBLOS)**

**Student Aid** – The Student Aid account has been established to provide assistance for those preparing for ministry by attending one of our seminaries or universities. A number of families have contributed to this fund.  
**Amount distributed: \$14,088**

**Music Fund** – The relatively new Music Fund has been established to support music ministries at St. Lorenz.  
**Amount distributed: \$195**

**St. Lorenz School Family Aid** – This fund was established to assist families with students attending our St. Lorenz School with tuition and fee expenses. The support needed is calculated through the TADS program and administered by our Executive Director.  
**Amount distributed: \$10,531**

**Communications/Operating/Caring Ministry** – Each year, following the donor's request, funds from this account are equally distributed between our Communications Ministry, our Operating Fund and our Caring Ministries through the Stephen Ministry program.  
**Amount distributed: \$60,867**



**Educational Enhancement Fund** – This fund was established to assist our called workers with ongoing educational experiences. The fund provides resources for continuing education opportunities to enrich a worker's professional experiences and to support their teaching and preaching activities.  
**Amount distributed: \$52,601**

**Health Insurance Support** – The cost of health insurance continues to climb. This account was established to provide support for retired pastors and teachers.  
**Amount distributed: \$361**

**Church Maintenance** – This account was established in 2016. It provides resources to help maintain our church properties.  
**Amount distributed: \$589**



**Building Program** – The Foundation has received funds directed to a congregational building program. This account has a balance of **\$246,067** available to assist with the construction of the Worship and Event Center.


## Dedicated Projects

# About the St. Lorenz Foundation

The St. Lorenz Foundation exists to support our Lord's work through His St. Lorenz congregation. The Foundation provides a vehicle for donors to make gifts that will continue to support the work of our Lord until Judgment Day.

The Foundation was formed in the fall of 1995. Founding board members included Harold Braeutigam, Stephen List, Morrall Claramunt, Jonathan Zehnder, Lynn Zuellig, Arnold Middeldorf and Pastor C.W. Hoesman. The team established the Foundation to provide ongoing support for our Lord's work through St. Lorenz Lutheran Church and School.

Today, the St. Lorenz Foundation receives gifts in many forms to support the ministry of St. Lorenz Lutheran Church and School. The funds are invested through the use of professional investment managers and monitored by a Finance Committee and the Board of Directors. Each year, the Foundation distributes a minimum of 5% of the corpus to support the grant requests forwarded by the congregation.

The St. Lorenz Foundation is limited to receiving grant requests from St. Lorenz Lutheran Church and School. The Board of Directors has established clear Management Principles that guide the granting process. Grant requests are processed by the Planned Giving and Estate Planning Committee and forwarded to the Board of Directors for action. Grant requests are not accepted from individuals or organizations outside the congregation.
